




U.S. Favorability in Europe












Overall, Eight-in-Ten Europeans Lack Confidence in Trump

Supporters of Right-Wing Populist Parties Are More Likely to Have Confidence in Trump


Confidence in U.S. President Donald Trump to do the right thing regarding world affairs among those with a/an...



A Shrinking Share of the Public in the EU Believes the U.S. Respects Its Own Citizen's Personal Freedoms




Fewer Now Say U.S. Takes Into Account Their Interests


Roughly Half of Europeans Say the U.S. is Less Involved in Tackling Global Issues

Compared with a few years ago, the U.S. is doing _____ to help address major global problems




In Europe, China Seen as Playing a Larger Global Role, Not the U.S.

Those saying _____ plays a more important role in the world today compared to 10 years ago




Europeans Say Germany, Not the UK or France, Plays a Larger World Role








Americans Are Less Convinced Than Others Trade is Good

Americans Have Consistently Felt Better About Trade Than About Trade Agreements






