### **Opening remarks**



António Martins da Costa President American Chamber of Commerce to Portugal

António Martins da Costa is currently Adviser to the Executive Board of Energias de Portugal (EDP), having been a member of the body for 15 years. He is also CEO and Vice-Chairman of the Board of EDP Brasil, Chairman and CEO of EDP Renewables North America and a member of EDP Renewables Board of Directors.

Prior to this, Mr da Costa worked in the financial sector as General Manager of Bank Millennium BCP (MBCP) and as member of the Executive Boards of MBCP's insurance, pensions and asset management companies. He previously served as Director of Eureko BV insurance group in the Netherlands and as Vice-President of the Executive Board of PZU insurance group in Poland.

He is currently President of AmCham Portugal, President of the Strategic Council of Proforum (Association for the Development of Portuguese Engineering), Vice-President of APGEI (Portuguese Industrial Engineering Association), Vice-President of the Portuguese Business Council for Sustainable Development (BCSD) and member of several Boards of Business Schools in Portugal.

He holds a degree in Civil Engineering from Faculdade de Engenharia do Porto (1976) and a MBA from Porto Business School (1989). He was a Teacher's Assistant at the Instituto Superior de Engenharia do Porto between 1976 and 1989.

## Keynote address



#### Pedro Siza Vieira

Minister of State, Economy and Digital Transition Portugal

Pedro Siza Vieira has served as Minister of State for the Economy and the Digital Transition in the XXI Constitutional Government since 2018.

He has a law degree from the Faculty of Law of the University of Lisbon. In his academic activity, he was a monitor at the Faculty of Law of Lisbon and Assistant at the Autonomous University of Lisbon and also a Visiting Professor at the Faculty of Law of the Universidade Católica Portuguesa and Universidade Nova de Lisboa.

He was also a trainer in postgraduate courses and courses promoted by several institutions, including the Universidade Nova de Lisboa, the Porto School of the Portuguese Catholic University and the Faculty of Law of the University of Coimbra in matters such as public procurement, administrative litigation, arbitration, law banking, project finance and insolvency.



As a lawyer, he was a partner at Morais Leitão, J. Galvão Teles e Associados, Law Firm and, from 2002 to October 2017, a partner at Linklaters LLP, being Managing Partner at the firm's Lisbon office between 2006 and 2016.

He was a member of the arbitration lists of the Commercial Arbitration Center of the Portuguese Chamber of Commerce and Industry, of the Commercial Arbitration Institute of the Commercial Association of Porto, Concórdia (Conciliation, Conflict Mediation and Arbitration Center), of the Mediation and Arbitration Center of Portuguese Chamber of Commerce in Brazil and CREL (Extrajudicial Dispute Resolution Center of the Ministry of Justice and Human Rights of Angola). He was a member of the Board of the Association of Law Firms of Portugal and President of the Portuguese Arbitration Association.

Bernardo Correia Country Manager Google Portugal

Mr Correia joined Google in 2008, leading the company's relationship with the consumer goods industry, after which he then lead Google's international relations with the media and entertainment industry, having actively developed a set of projects with content producers from around the world, aiming to optimise and profit from the use of digital technologies.

Over eight years, he was involved in creating new methodologies to help brands assess the value of the digital - including search engines, online video, display, programmatic marketing and mobile - and supported the creation of new models of content for today's digital distribution platforms with the biggest Hollywood movie studios, game companies and music publishers.

In 2016, he returned to Portugal as the Country Manager for Google Portugal. Mr Correia directs the company's operations in the country and, under his leadership, several key projects have been launched in order to expand Google's support to the country, including the digitisation of Portuguese artworks, in partnership with museums, on Google Arts & Culture.
